How did the Fund perform last year?

VP Large-Cap Growth seeks investment results, before fees and expenses, that track the performance of the S&P 500® Growth Index (the "Index").

The Fund invests in securities that ProFund Advisors believes, in combination, should track the performance of the Index. During 2024, growth outperformance over value drove outperformance relative to the S&P 500® Index.


For the year ended December 31, 2024, the Fund had a total return of 33.78% and an average daily statistical correlation of over 0.99 to the daily performance of the Index. For the same period, the Index had a total return of 36.04% and a volatility of 17.79%.

Primary factors affecting Fund performance include the total return of the securities held by the Fund, expenses, transaction costs, the volatility of a Fund's index, and other miscellaneous factors.
