- Overweighting a market segment without additional cash

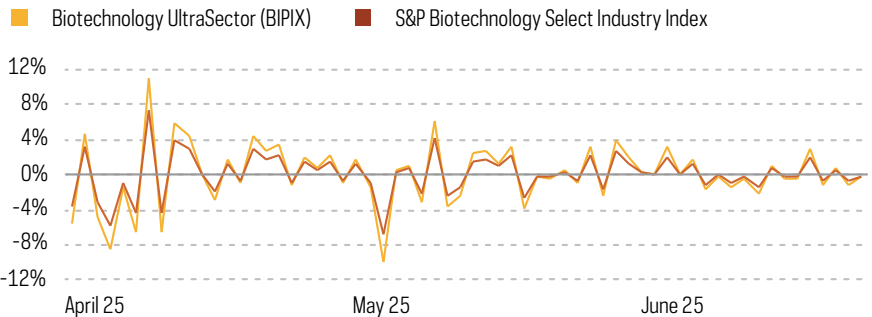

Daily return during 2Q 2025

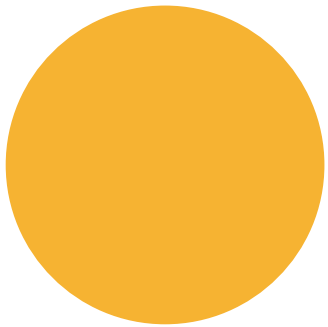
