- Overweighting a market segment without additional cash



It is a float-adjusted, market capitalization-weighted index. It is not possible to invest directly in an index.



Many ProFunds seek daily investment results that correspond, before fees and expenses, to a multiple (e.g., 2x, -2x) of the daily performance of its underlying benchmark (the "Daily Target"). While these Funds have a daily investment objective, you may hold Fund shares for longer than one day if you believe it is consistent with your goals and risk tolerance.
