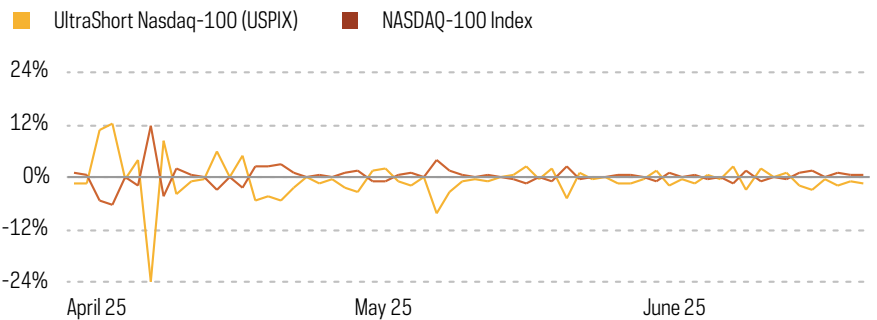

Daily return during 2Q 2025

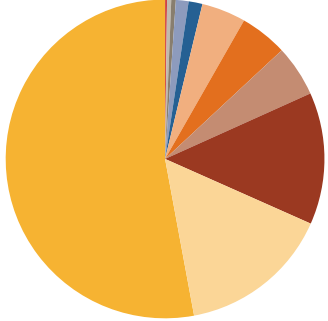
